AGREEMENT

In consideration for participation in an event sanctioned by the American Herding Breed Association (AHBA). I agree to assume all responsibility for any claim, loss or damage, of whatever kind or nature, whether to person or property, which may be caused at or near this event, either directly or indirectly, by me or the dog or dogs I have entered in or brought to this event. I further agree that I will hold the AHBA, its officers, directors, agents and members harmless and defend them from any and all liability for any injury, claim, damage or loss, of whatever kind or nature, whether to person or property, caused at or near this event, whether directly or indirectly, by me or any dog I have entered in or brought to this event. I agree to indemnify the AHBA, its officers, directors, agents and members for any loss, cost or expense including attorney's fees and costs, to which the AHBA, its officers, directors, agents or members might be subject as a result of any claim, suit, loss or damage caused in any way by any act or negligence on my part or on the part of any dog or dogs I have entered in or brought to this event. I acknowledge that while the AHBA may provide sanctioning for this event with regard to the issuing of titles, it does not have and does not exercise control over the conduct of the event or those present. I certify and represent that the dog or dogs I have entered in or brought to this event is/are not a hazard to other dogs, other animals, or to people.

I (we) agree to hold this club, its members, directors, governors, officers, agents, superintendents or show secretary and owner or lessor of the premises and any employees of the aforementioned parties harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the Herding Test and Trial premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned, or by the negligence of any other person, or any other causes.

I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting there from, sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in the Herding Test or Trial, howsoever such injuries, death or damage to property may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or any of their employees, agents, or any other persons.

I (we) acknowledge that the "Rules Applying to Registration and Dog Shows" and the "Rules for Herding Tests and Trials" have been made available to me (us) and that I (we) agree that the club holding this Herding Test or Trial has the right to refuse this entry for cause which the club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the Herding Trial and of the opportunity to have the dog tested or judged and to win ribbons or trophies, I (we) agree to hold the AHBA, San Pasqual Valley Herding Club, or Action K9 Sports, their members, directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties harmless from any claim for loss or injury which may have been alleged to be caused directly or indirectly by this dog.

I (we) will pay for any livestock injuries or replacement value in the event of death of any livestock by my (our) dog. In case of any injury to any stock caused by the dog entered, I (we) will assume total responsibility for any damage I (we) agree to pay the full market value of the injured animal in case of serious injury, or the veterinarian bill if the injury is slight.

Exhibitors Information

CANADIAN EXHIBITORS MUST SUBMIT ENTRES WITH CHECKS DRAWN ON U. S. ACCOUNTS OR WITH INTERNATIONAL MONEY ORDERS IN U.S. FUNDS

RETURNED CHECKS do not constitute a valid entry fee. If a check is returned, fees must be paid in guaranteed funds; checks will not be accepted as a replacement. The Secretary will add a collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis. Entry fee will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or judge or barred from competition by action of Show Committee.

The Show giving Club, the Show Secretary, their agents, employees, etc. assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assume no responsibility for injury to children. No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. Entries will not be accepted without signatures on forms sent by mail.

Changes, additions or corrections to entry forms must be received in writing or email prior to close of entries. Refunds of \$5.00 and less will not be issued due to cost of processing.

Action K9 Sports Disaster & Emergency Plan for People & Dogs

Cell and Landline phones available.

FIRE: Dial 911 All dogs should be crated or leashed securely and owners/handlers must make sure that they, their dogs and vehicles are out of driveways that Fire and Emergency vehicles would use for approach to the site of the fire. Escondido Fire Department responds at this site.

Forest Fire: All people and their secured dogs should immediately follow fire/emergency personnel evacuation directions and orders

Earthquake: Remain on the site with dogs secured. Use arenas for emergency animal housing if necessary. Use barn or house if safe. Wait for instructions via radio.


